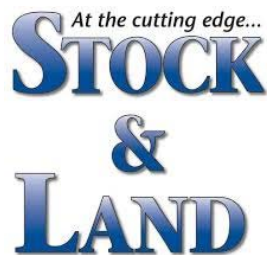

O'Sullivan's Australian Yard Dog Championships held at the Australian Sheep and Wool Show, Bendigo, 14<sup>th</sup>, 15<sup>th</sup> and 16<sup>th</sup> of July 2017.

There is \$10,000 up for Prize money.

Entry Fees are as follows:

OPEN - \$20, IMPROVER - \$15, NOVICE - \$15, MAIDEN- \$12

No Bitches can compete if they are in season.

All interstate competitors will need to pay a VYUFDA supporting membership of \$30. This enables interstate competitors to compete in Victoria for a twelve month period. Option is listed on the entry form for Interstate competitors; Interstate form is attached to be filled out before trailing.

Camping is available at the venue: Non powered sites - \$15 for the 3 nights

: Powered sites - \$66 for three nights

Gate entry - Option 1 - \$66 for Associate Membership which covers 2 Gate Passes and car parking for the 3 days,

Option 2 - \$22/person plus \$5 parking/ per day.
