- ✧ Each run includes a \$5 sheep levies for the hire of the sheep.
- ✧ All dogs must be registered with the W.K.C - A2 grade Appendix or higher registered dogs.
- ✧ No bitches in season to be worked but may be substituted. Trial committee must be advised prior to commencement of trial if substitution is needed.
- ✧ No refund on paid fee's for Scratching.
- ✧ Novice Dog - is a dog, which has never won any recognized or advertised sheepdog trials, competitions or challenges excluding one Encourage trial.
- ✧ These trials will be conducted under the rules and regulations of the Working Kelpie Field Trial Committee.
- ✧ All dogs are to be nominated with Official Prefix & W.K.C Registration number.
- ✧ Nominated dogs that are to be worked by a different handler than nominated, you must notify committee of new handler before the trial they are entered in commences.
- ✧ You must notify Organizing committee with in the event of Protest or Complain there will be a levies of \$20 fee for your protest or complains to be heard by 2 committee & 1 W.K.C committee members.
- ✧ In the event of your protest or complain being up held your \$20 will be refunded but if it is defeated you will forfeit the payed fee.
